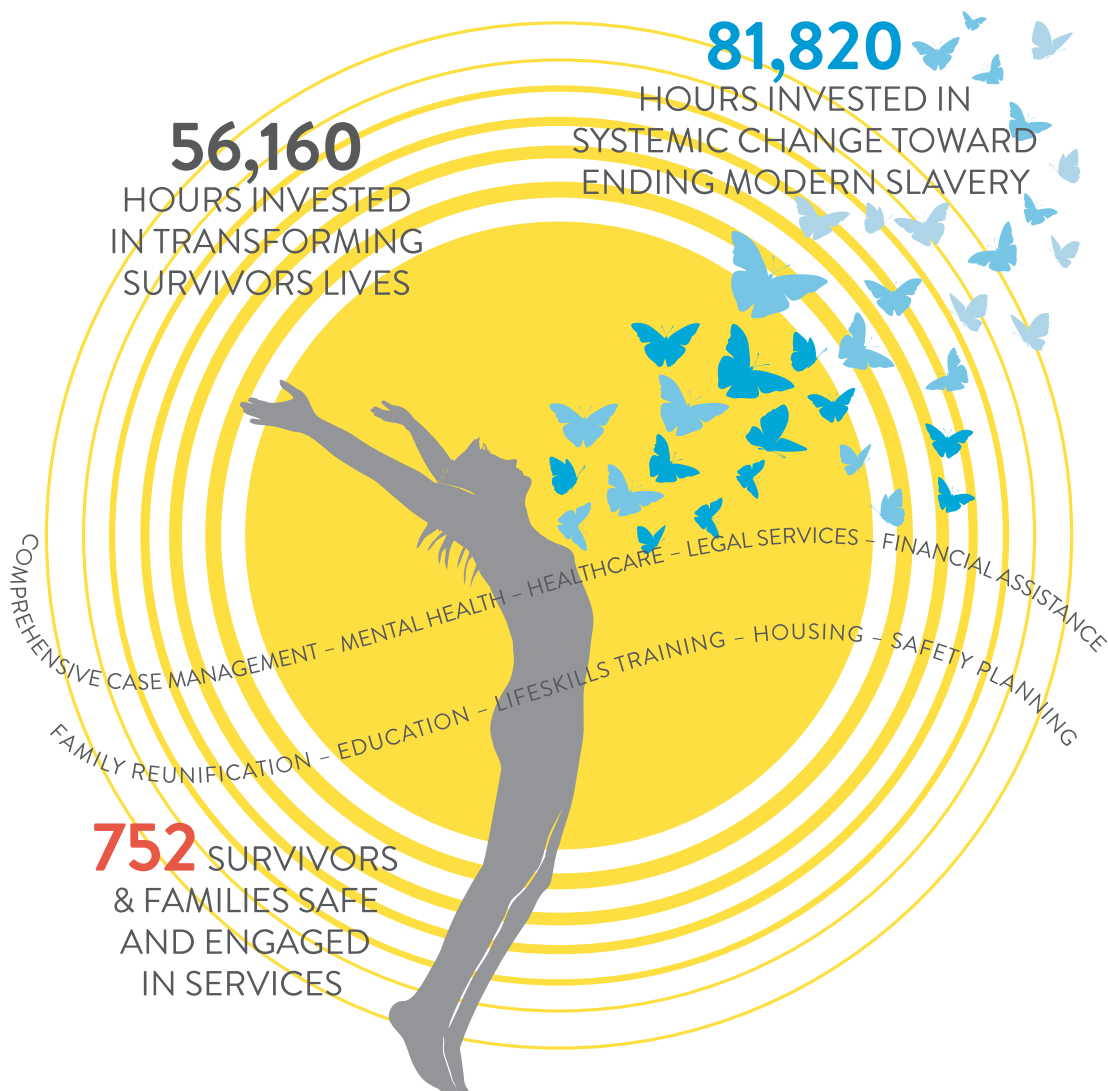
MISSION STATEMENT

OUR STORY

As one of the first anti-trafficking organizations in the country, CAST is a key leader of the US anti-trafficking movement and is known for its model programs across the globe. Founded in 1998 in response to the discovery of 72 Thai workers that had been kept for years in slavery and debt bondage in Los Angeles County, the organization has been at the forefront of the issue in L.A., California, and across the U.S., including opening the first-ever shelter exclusively for trafficking victims. Today, through partnerships with over 100 cultural and faith-based community groups, healthcare organizations, government agencies and law enforcement, CAST provides comprehensive support at every phase of a human trafficking victim's journey to becoming an empowered survivor. Serving as a crucial bridge between practice and public policy, CAST is a learning organization that puts its evidence-based data to work on creating systemic change. By combining its model of social and legal services for survivors with a leadership and advocacy model, survivors are shaping the national dialogue and public policy. Empowered by CAST Survivor Leadership Programs, survivors are powerful voices at the forefront of the anti-trafficking movement. It is this bold leadership and innovation that won CAST the prestigious Presidential Award for Extraordinary efforts in Combatting Human Trafficking.

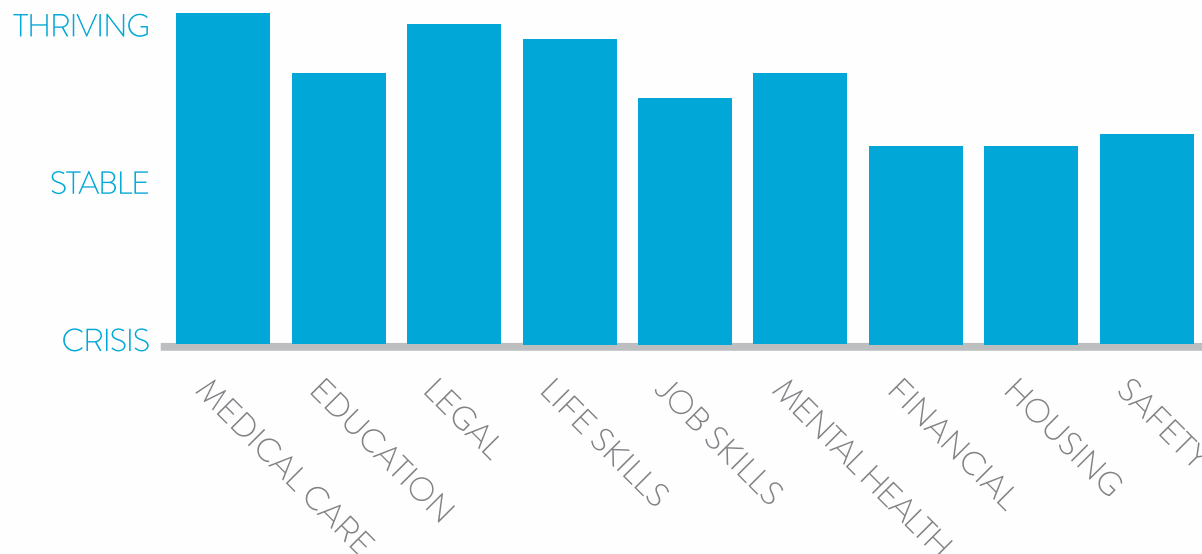
LEADING THE WAY IN SURVIVOR TRANSFORMATION

HOTLINE & EMERGENCY RESPONSE

CAST provides an immediate and around the clock response to victims of human trafficking through its 24 hours a day, 7 days a week hotline, and serves as a resource to the community for referrals, technical assistance and reporting tips on potential human trafficking cases. Our dedicated emergency response team answers calls and springs into action at all hours to meet with survivors and ensure the safety and well-being of victims when they first escape.

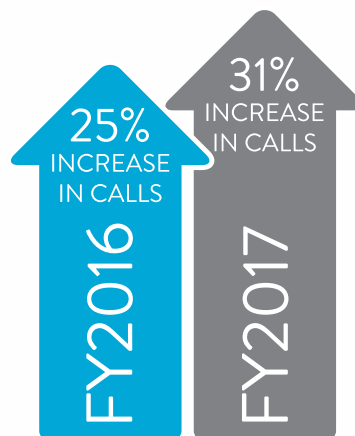

MARIPOSA HAVEN:

HOME FOR HUMAN TRAFFICKING SURVIVORS

A Transitional Housing Program, Mariposa Haven provides housing for trafficked women and transition-aged youth (TAY) who would otherwise be homeless and vulnerable to re-exploitation. The first of its kind, Mariposa Haven is a vital part of CAST's continuum of care, and is designed to help survivors establish safety, healing, and self-sufficiency, while attaining the skills needed to expand their own supportive networks. Designed as a haven for survivors who have the greatest safety needs, the program has 10 beds in a home-like environment and is located in an undisclosed location in Los Angeles while the rest of CAST's clients are housed in partner facilities.



YASSMIN

Forced into domestic servitude by a royal family in the Middle East for years, Yassmin was brought to the US. Yassmin found herself sitting on a bus stop bench scared, alone, and lost after finding the courage to escape from her traffickers. Selma, a former CAST client, was leaving her job when she came upon Yassmin sitting at the bus stop crying. Realizing Yassmin too was a victim of trafficking, Selma immediately called CAST, and Yassmin moved into

Mariposa Haven where she felt safe for the first time in years. Yassmin worked hard to learn English by attending ESL classes and practicing with shelter staff who placed her in a new fulltime job that she loves, moved her into permanent housing, and reunited her with her child and husband after years of separation.

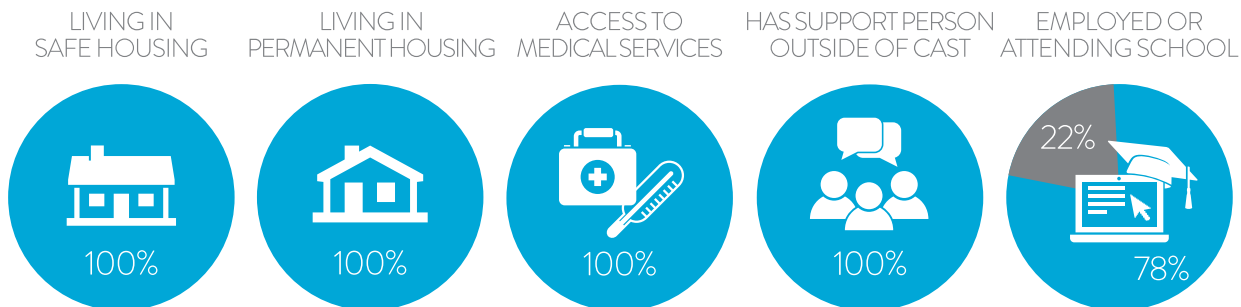
COMPREHENSIVE CASE MANAGEMENT

CAST has spent nearly 20 years developing and implementing a comprehensive, trauma-informed and victim-centered Case Management Program for survivors of human trafficking. Utilizing an empowerment approach, CAST's Case Management Program provides a coordinated continuum of care to meet the emergency response and long-term needs of all types of human trafficking survivors living in Los Angeles County, and is uniquely designed to respond to the diverse needs of survivors in reaching their potential. Case managers go the extra mile; clients are regularly assessed to provide every avenue possible to achieve their goals. At graduation, our clients show clear progress across the board. Often, the gains are strongest in areas such as health and life-skills where they were initially the most vulnerable.

EVELYN

Evelyn is a young woman who was recruited into sex trafficking by an acquaintance when she was just 16 years old. Lured with the promise of becoming a model, she arrived at the job site only to be forced into the commercial sex trade and subjected to terrifying emotional and physical abuse. Managing to escape but unsure where to turn, she moved from shelter to shelter but always felt that she wasn't getting the help she truly needed. Finally, she was referred to CAST and her life changed. Feeling safe for the first time at CAST, she began to start healing and setting goals with her case manager. Today, Evelyn is certified in phlebotomy and graduated at the top of her class! With more goals to achieve, she is building a stronger support network and learning how to become financially independent. Evelyn has a great future ahead of her.

YOUTH PROGRAM

CAST's youth program recognizes the specialized needs of trafficked minors and transition-aged youth (TAY) and provides group activities focused on empowerment, positive experiences, and education; comprehensive case management and advocacy services with interventions geared towards youth; individual assistance navigating government systems, such as probation and the Department of Children and Family Services; and internships for TAY seeking to build job skills and professional development through direct work experience and mentoring.

CAST is one of the only legal services providers in the U.S. that comprehensively assesses and serves the full spectrum of legal services trafficking survivors need. Specializing in immigration, crime victims' rights, family law, civil remedies and criminal advocacy, our expert team of lawyers win justice for survivors.

KARLY

Thirteen-year-old Karly was awarded more than \$93,000 in restitution from the traffickers who pleaded no contest last July to one felony count each of human trafficking and slavery.

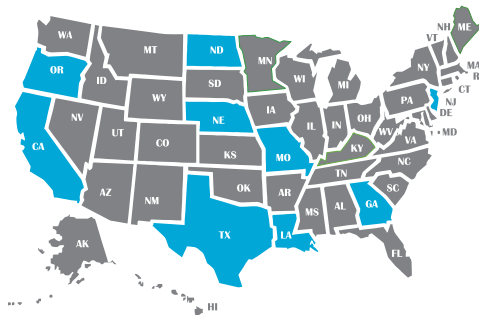
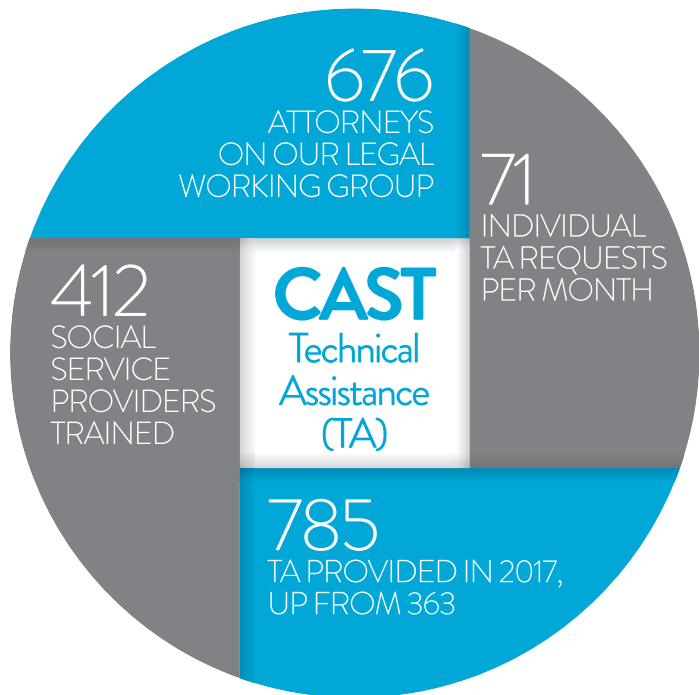
When Karly was eight, the trafficker paid a coyote to smuggle Karly out of Honduras. Once in the United States, Karly was forced for two years to work six days a week, often 50 hours per week at a restaurant in Bellflower. When she wasn't at the restaurant, she was ordered to clean the home of the trafficker.

CAST, along with partner Bet Tzedek, represented Karly and helped calculate the restitution request, granted in full and including lawful wages, meal and rest breaks, minimum wage liquidated damages, and pre-judgment interest. The trafficker was sentenced to five years in state prison for human trafficking and slavery.



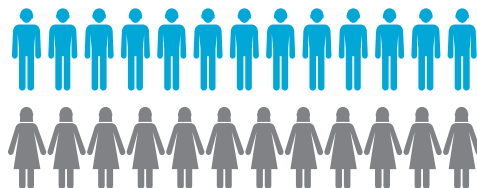

ADVOCACY

Drawing from two decades of direct experience working with victims of human trafficking, CAST has sponsored cutting-edge legislation on victim protections and human trafficking prevention policies, and contributes its expertise to the media to ensure coverage of human trafficking is based on the real experiences of survivors. Serving as the go-to resource for policy leaders and the media, CAST's public policy agenda centers around survivor experiences and invests in the training of survivors as advocates and leaders to impact systemic change. JASIEL

Fourteen-year old Jasiel crossed the border on his own after living on the streets in Mexico since the age of 11. After begging and taking odd jobs to survive, a coyote approached him and said he could help him reunite with his family in the US for \$3,000 by working in a furniture shop. For two long, hard years he was forced to work and sleep in the owner's garage. CAST fought for Jasiel to remain in the United States. Eventually, he was granted Legal Permanent Residence. After Jasiel graduated from our empowerment programs this year, he joined CAST's Survivor Leadership Program where today, he is using his experience- and his voice- to change laws that protect children who are trafficked and for funding that will ensure that all victims in CA will have access to trauma-informed comprehensive services.

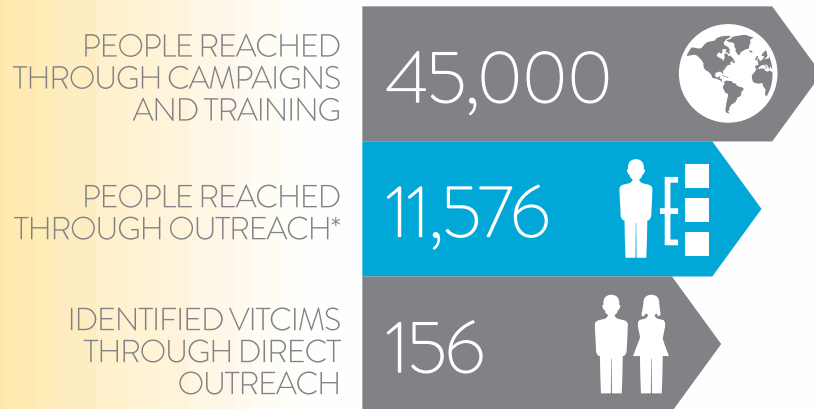

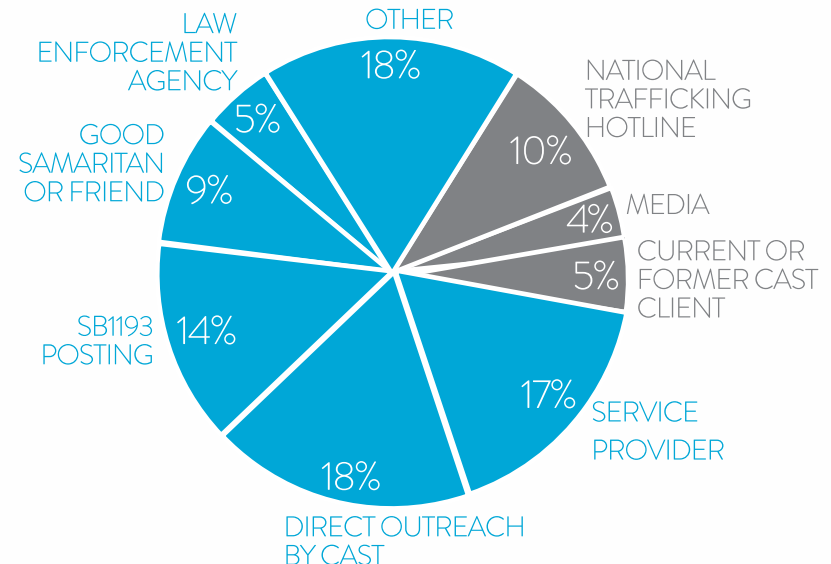

PARTNERSHIPS

Actively enforcing SB 1193, known as the Human Trafficking poster bill, the City Attorney's Office has sent out 520 letters to businesses that are required to post the information, with hundreds more letters to be sent leading up to the January 2018 Human Trafficking Awareness Month. The City Attorney's Office has filed civil enforcement actions against motels used as bases for human trafficking and other illegal activities, and mandated that motels train their staff in human trafficking detection, hire adequate security guards, and install video surveillance camera systems. The City Attorney's Office generously gave the monetary proceeds of settlements to CAST and other anti-trafficking service providers following cases against Motel 6 and the Valley Inn.



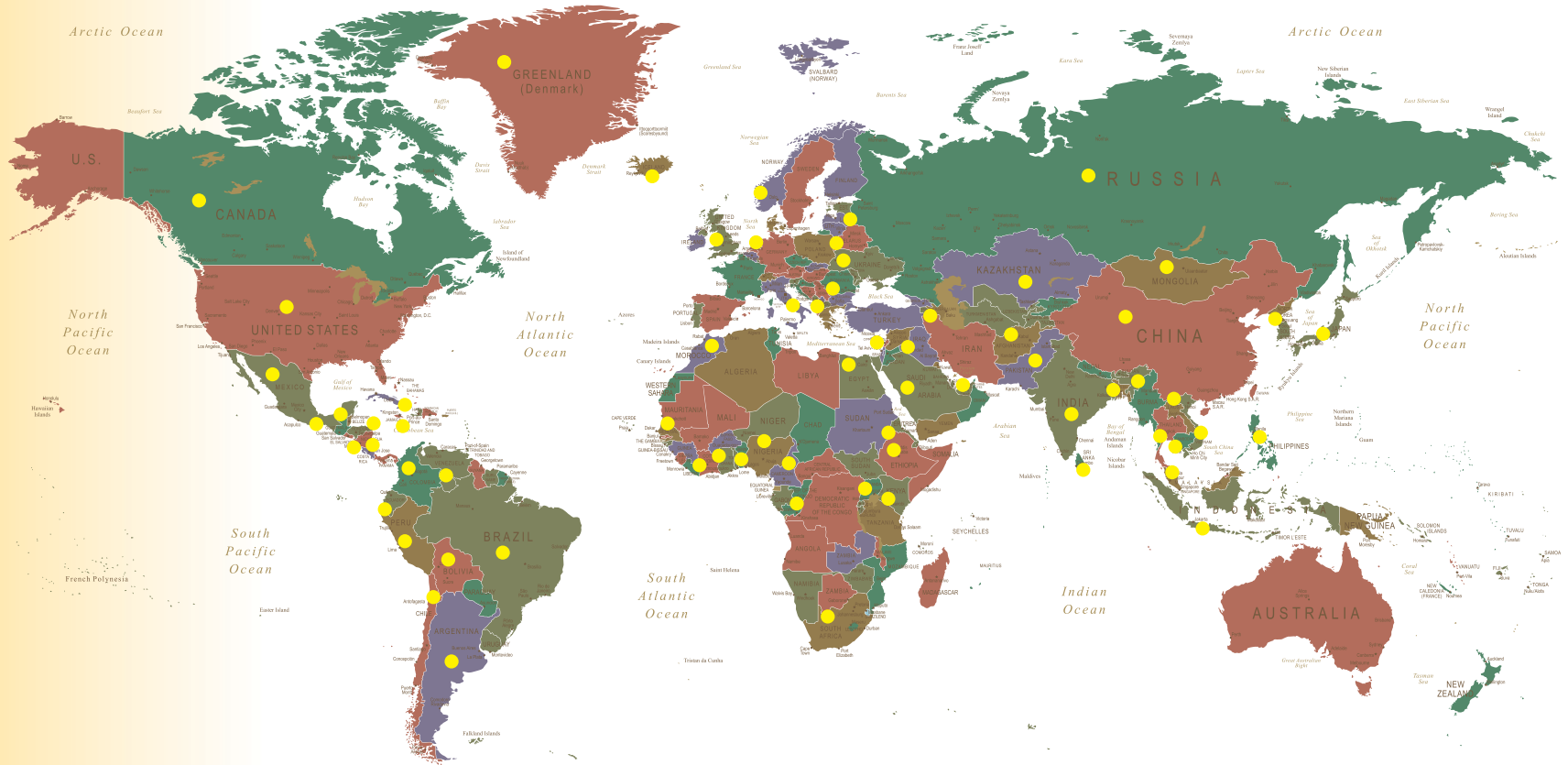

The Los Angeles Regional Human Trafficking Task Force, an innovative multi-disciplinary partnership spearheaded by CAST and the Los Angeles County Sheriff's Department, provides trauma-informed care to trafficking victims and investigates trafficking crimes. With more than 30 members, this cutting-edge collaborative model is the largest co-located taskforce in the country that is actively responding to breaking cases of human trafficking. In partnership with Sheriff Jim McDonnell, CAST is proud of the innovative taskforce model we envisioned and created together, and grateful for the collaborative impact we are making in the lives of survivors and our communities.
