## **HUMAN TRAFFICKING VICTIM ASSISTANCE (HV) PROGRAM**

The following twenty-one projects received Cal OES grants from the continuing 10 million in specialized human trafficking services from the general fund since 2015\* or

2016\*\*. These programs originally received funding though a competitive grant process administered by Cal OES for a 24-month grant period which was then extended by Cal OES to 2021. In 2021, all programs will be required to reapply through the Cal OES competitive grant process.

During the period of April 1, 2016 to June 30, 2020, a total of 13,650 victims were served, and 394,317 services were provided (victims may receive multiple services, including of the same type).
